

## “Refer a Friend” Promotional Terms:

2. References to “our” and “we” and “us” shall mean Kaplan International Colleges U.K. Limited, whose registered office is at Palace House, 3 Cathedral Street, London, England, SE1 9DE and references to “you” shall mean a full-time student who is currently studying at one of the following institutions:
  1. University of Brighton International College (**UBIC**);
  2. University of Brighton (having progressed from UBIC with Kaplan);
  3. University of Bournemouth International College (**UBIntCol**); or
